2008 RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK,  
AND INDEMNITY AGREEMENT**

IN **CONSIDERATION** of being permitted to participate in any way in any 2008 Hoosier Mountain Biking Association (HMBA) events and activities, I, for myself, my personal representatives, assigns, heirs and next of kin:

- 1.) **ACKNOWLEDGE**, agree, and represent that I understand the nature of **MOUNTAIN BIKING** Activities and **TRAIL BUILDING** Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge, agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
- 2.) **FULLY UNDERSTAND THAT** (a) **MOUNTAIN BICYCLING ACTIVITIES AND TRAIL BUILDING ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, LOSS OF LIMB, AND DEATH ("Risks")**; (b) these Risks and dangers may be caused by my own actions, inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or **THE NEGLIGENCE OF THE RELEASEES "NAMED BELOW"** (c) there may be **OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES** either not know to me or not readily foreseeable at this time; and I **FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS AND DAMAGES** I incur as a result of my participation or that of the minor in the Activity.
